





by German states as at Q4 2022 in % of total loan cover volume for Germany\* (€30.6bn)



#### Risk management – Limits


In addition to already existing risk management systems for controlling and monitoring of the credit risks, the following additional limits are implemented for the cover pool:

- by largest single borrower
- by the ten largest borrowers
- by region (German federal states)
- by total limit for commercial properties
- by selected property types


