with responsibility also for CEE. Most recently, he was Chief Finan-

Francesco Giordano started his career as an economist at S&P

Group more than 20 years ago. After that he was working at San

Paolo Bank and at Credit Suisse First Boston in London.

Lutz Diederichs joined HypoVereinsbank in 1990 and has since then

held various positions, including Senior Director for large corporates

& Commercial Real Estate Financing as well as Head of Corporate

Division. In January 2009 he was appointed Member of Manage-

ment Board HypoVereinsbank, responsible for Firmenkundenges-

chäft, later also for Corporate Banking and Markets & Investment

Banking. From October 2009 until January 2013 has taken over re-

sponsibility as a board member for Corporate & Investment Bank-

ing. Since January 2013 he is Member of Management board Com-

mercial Banking, Division Unternehmer Bank.
